Biographical/Historical Note

The Chautauqua County Court of Common Pleas served as the principal legal court in Chautauqua County from 1821-1846. Benjamin Walworth held the office of Judge of the Court of Common Pleas for thirteen-years, beginning his tenure in 1828. In 1846, the County Court replaced the Court of Common Pleas as the chief legal agency of the county, this change was brought about by the New State Constitution of the same year.

Scope and Content

This collection contains points of argument, briefs, notes, and correspondence relating to civil cases tried in the Chautauqua County Court of Common Pleas.
