The Village of Fredonia was incorporated in 1829 and is one of only twelve villages in New York State that remain incorporated under a charter. The village is governed by a Mayor and Board of Trustees, each serving four-year terms. This governing body oversees all municipal departments that serve the village, including, but not limited to, Fredonia's Code Enforcement, Fire Department, and Public Works.

Scope and Content

This collection contains administrative, legal, financial, and ephemeral records from the Village of Fredonia's Board of Trustees and its various municipal departments.

This collection has been arranged by municipal department, with each department's records organized by item type and ordered chronologically.
